

## RESOLUTION AUTHORIZING EXECUTION OF REVISED LICENSE AGREEMENT BETWEEN THE NORTH BERGEN MUNICIPAL UTILITIES AUTHORITY AND HUDSON VIEW CAR WASH, LLC

WHEREAS, the North Bergen Municipal Utilities Authority ("AUTHORITY") is presently the owner of the property located at 7117 River Road, North Bergen Township, New Jersey ("the Property"), a portion of which is currently used by Hudson View Car Wash ("CAR WASH"); and

WHEREAS, the AUTHORITY and the CAR WASH wish to memorialize a long term License Agreement whereby the AUTHORITY will provide a License to CAR WASH to utilize the Property, for twenty-five (25) years or upon expiration of the CAR WASH's operation, whichever occurs first, subject to the terms and conditions enumerated in the License Agreement; and

WHEREAS, the AUTHORITY wishes to allow the CAR WASH to use the Property for purposes of operating its business in exchange for indemnification and payment of a portion of the construction cost for the Property in addition to the other terms and conditions of the License Agreement; and

WHEREAS, the AUTHORITY and the CAR WASH have mutual interests in performing the terms and conditions of the License Agreement; and

WHEREAS, the revised License Agreement to permit the CAR WASH's use of the Property is attached hereto and incorporated by referenced herein.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NORTH BERGEN MUNICIPAL UTILITIES AUTHORITY that the attached revised License Agreement be and hereby is accepted and approved, with such changes as the Executive Director and Authority Attorney determine to be necessary to effectuate the purposes of this Resolution.

**BE IT FURTHER RESOLVED** that the Executive Director, Authority Attorney and any other necessary official, officer or employee of the Authority be and hereby are authorized to execute any and all documents and to take any and all actions necessary to complete and realize the intent and purpose of this Resolution, including execution of the License Agreement.

The garage will house the proposed generator and transformer and provide the additional storage needs resulting from this project. This change order is for the garage concrete work only; and

WHEREAS, after negotiation with the Authority's Engineer, Paulus Sokowlowski & Sartor Engineering, the contractor agrees to perform the work as set forth in the proposed Change Order for a total amount of \$ 479,758.00, which price represents a fair and reasonable cost for the work; and
